Commission Business

• Action Item A: Commercial Site Plan - Caleb Stoker, Elwood Crossing Lot 8, Powerline Road 5400 West. No presenter was present. Commissioner Hamson stated that it is standard procedure to table an action item when no representation is at the meeting to ask questions and get clarification with. Commissioner Crouch motioned to table the commercial site plan approval for Elwood Crossing Lot 8 due to no representation at the meeting, Commissioner Shimek seconded the motion, all in favor, motion passed.

Work Meeting

 Discussion Item A: Discussion of the town re-zone initiative, review draft letter/announcement, and draft flowchart for action at the next meeting. Commissioner Hamson will send out an updated/condensed letter/announcement.

- From the planning commission meeting, the following questions were answered.
- Re-zone process Is Step 5: Town Council Public Hearing and Decision accurate? Gina said yes, to make sure citizens are given every chance.
- Open House Gina marked September 23rd as open house. Advertising: Utility bill, public notice website, town hall window, elwoodtown website, facebook. She recommended we also add a newspaper notice. Gina also recommended that we have an action item to recommend to TC to approve and send out the open house announcement. So this would mean that it would be on to agenda Sept 9 and we can ask Gina to hold the water bill to include this open house notice.
- -Open House Zoning Analysis I explained that at the open house we would want to have the ability to print particular Zoning analysis sheets for citizens and Gina said she could be available to do that printing at the open house.
- -Open House Current Zoning Map foam board Gina said that the form board we have is nearly current. There may need to be a piece turned green.
